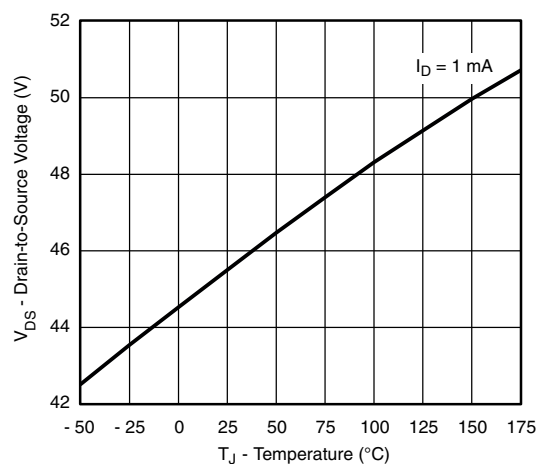

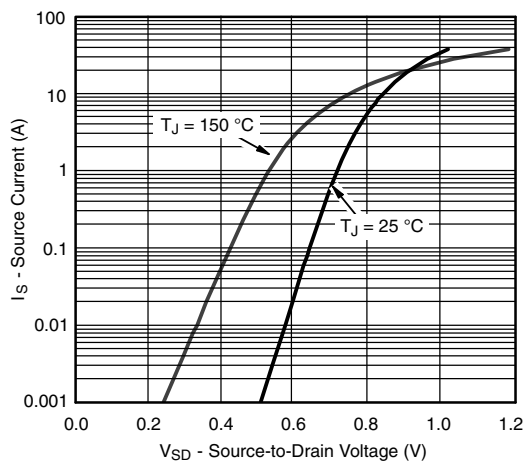

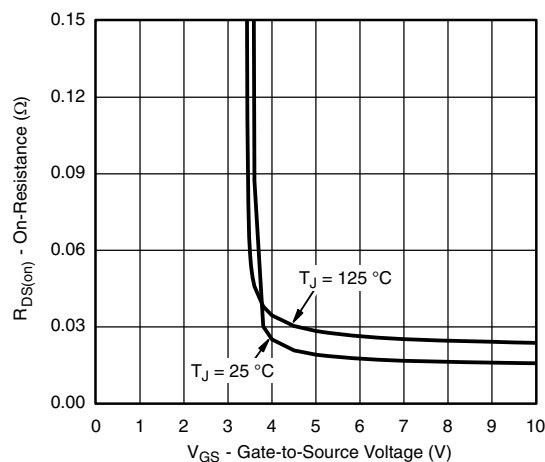
**On-Resistance vs. Drain Current**



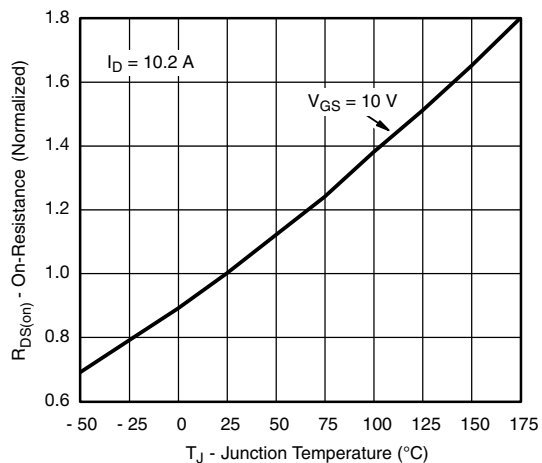
**Drain-Source Breakdown vs. Junction Temperature**



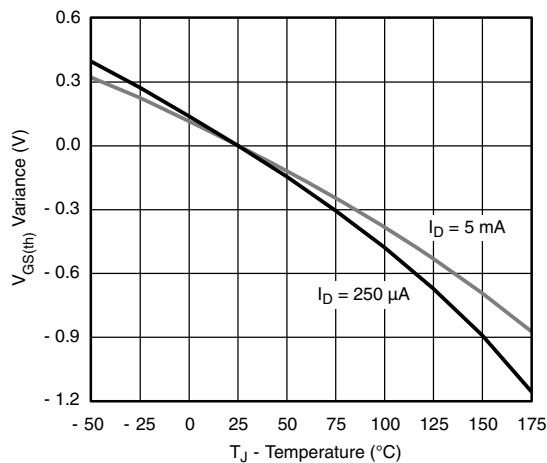
**Source Drain Diode Forward Voltage**



**On-Resistance vs. Gate-to-Source Voltage**



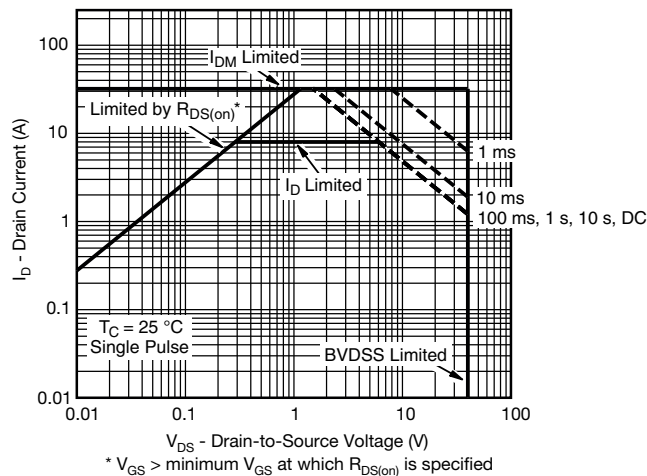

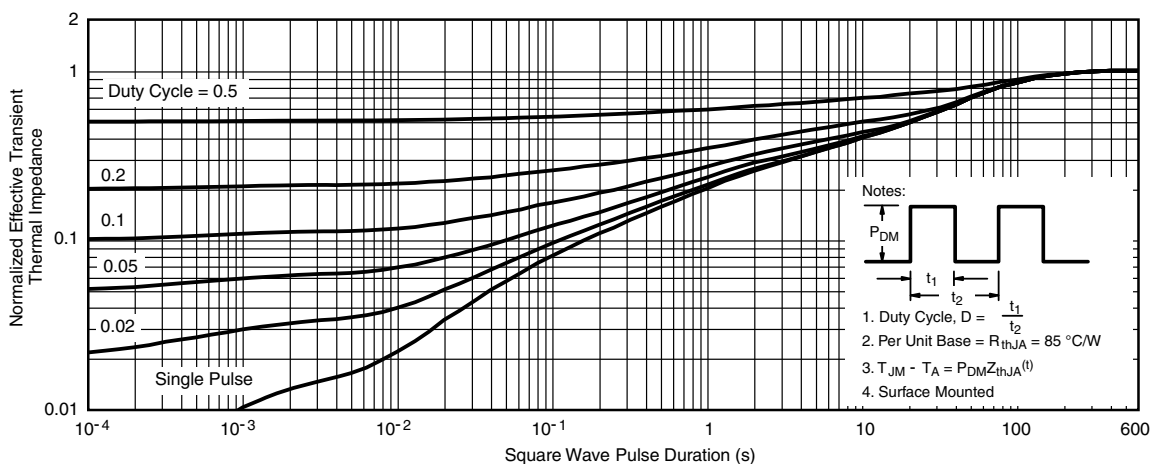

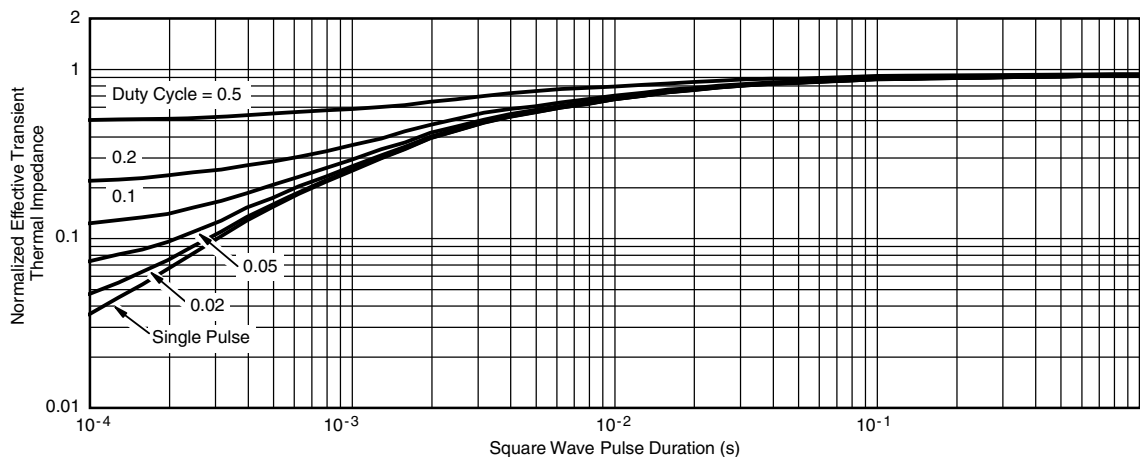
**Safe Operating Area**

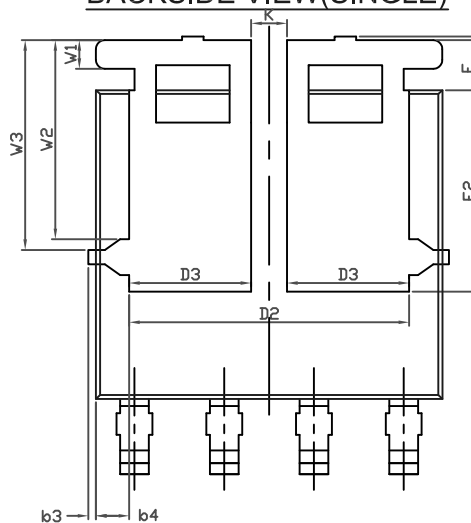

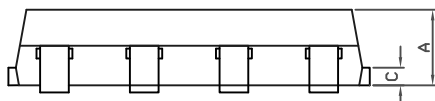
