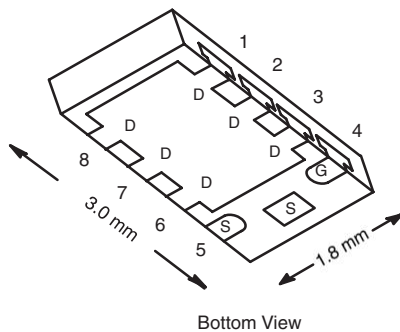

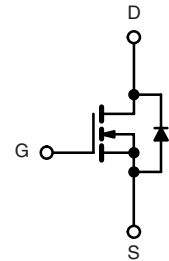
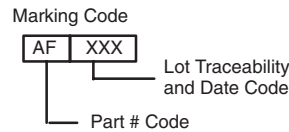
PowerPAK ChipFET Single
