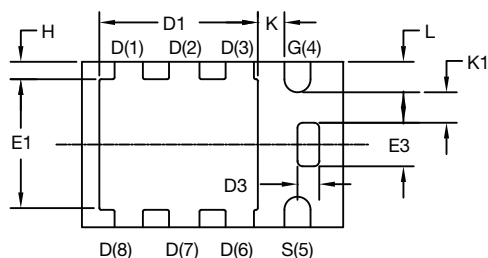
Side view of single



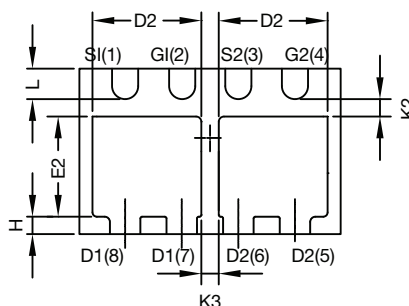
Side view of dual

Backside view of single pad



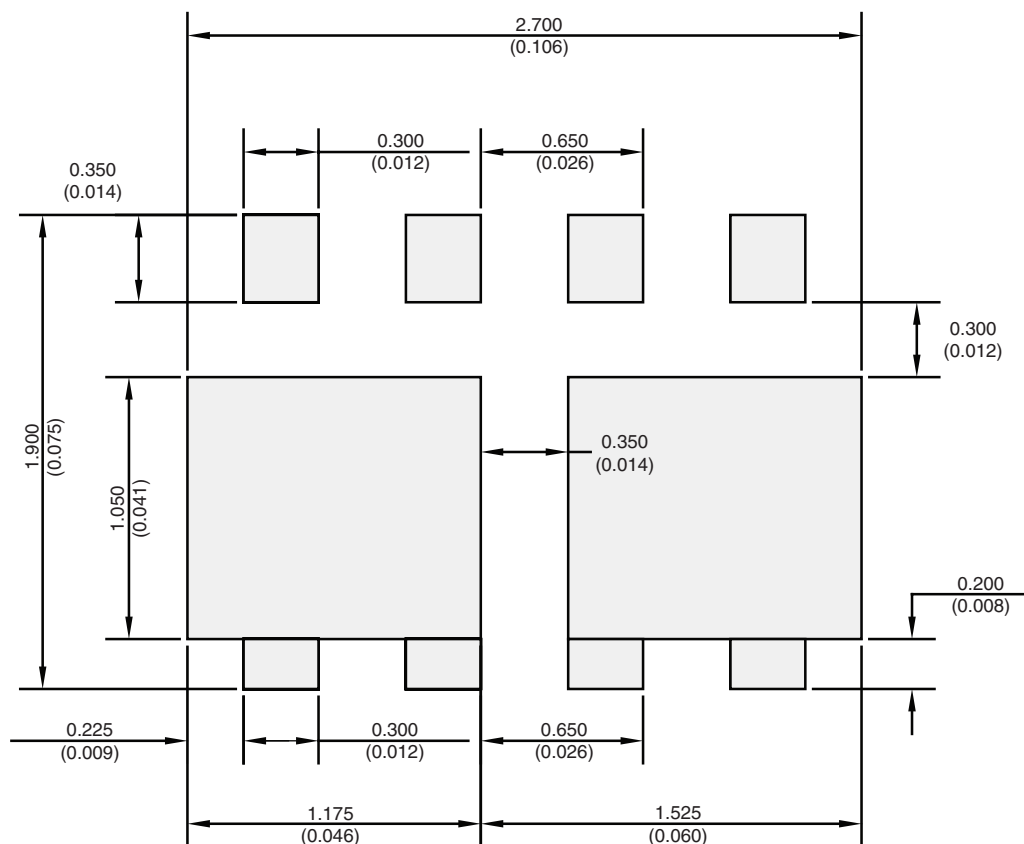
