


Figure 1. Collector Dark Current vs. Ambient Temperature




Figure 2. Relative Photo Current vs. Ambient Temperature




Figure 3. Photo Current vs. Collector Emitter Voltage





Figure 4. Photo Current vs. Illuminance




Figure 6. Relative Spectral Sensitivity vs. Wavelength





Figure 7. Relative Radiant Sensitivity vs. Angular Displacement
