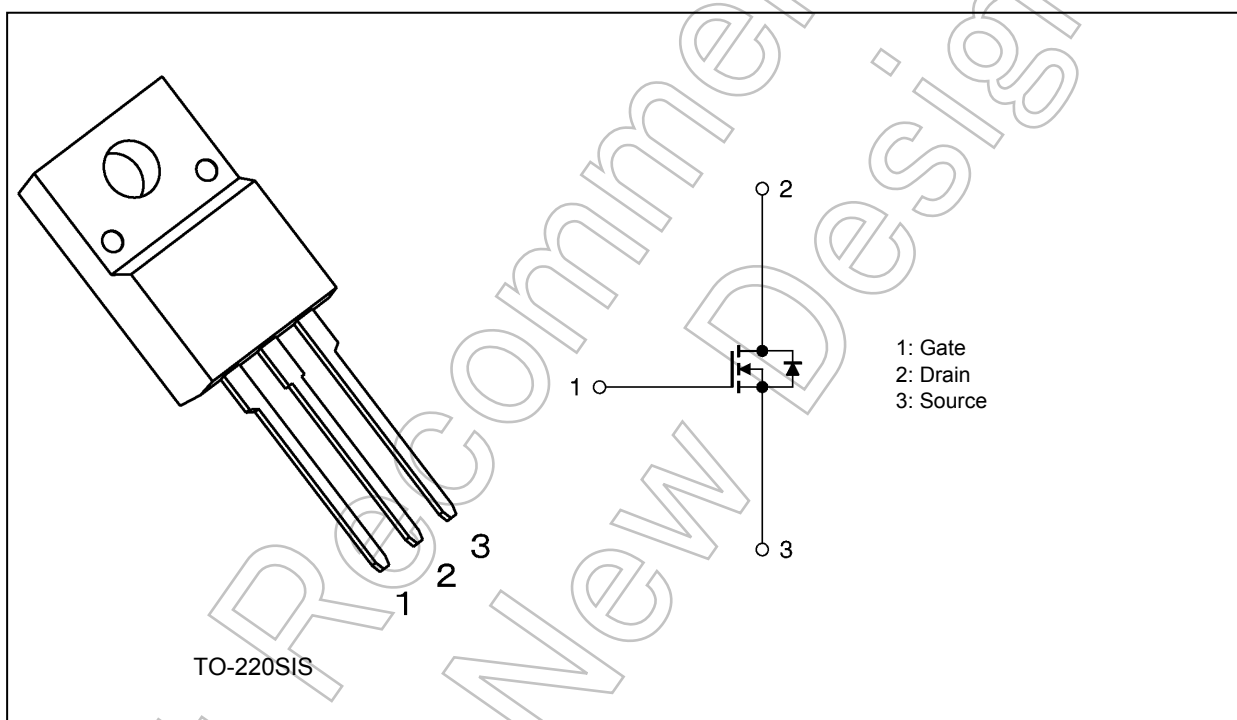

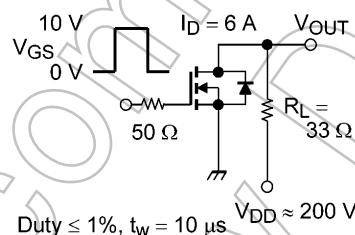


Fig. 6.2.1 Switching Time Test Circuit

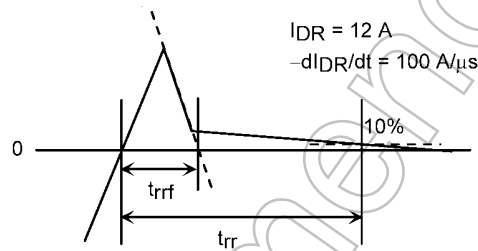


Fig. 6.4.1 Reverse Recovery Time

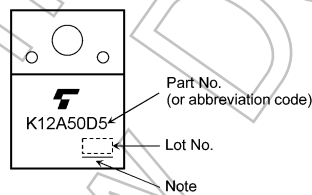


Fig. 7.1 Marking

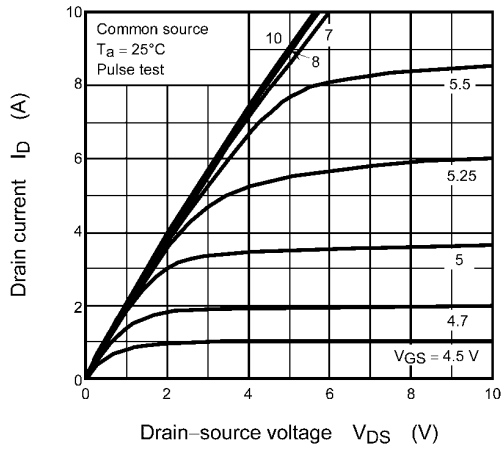

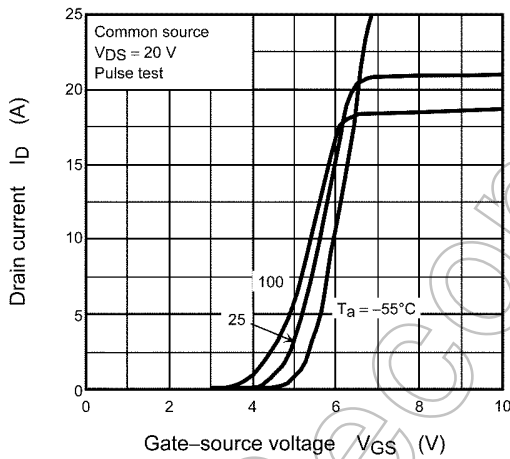

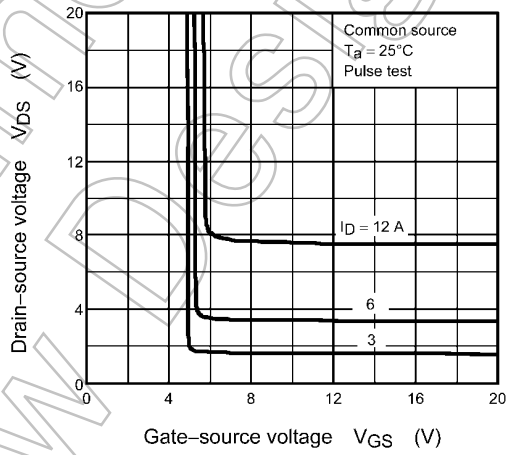
**Fig. 8.1**  $I_D - V_{DS}$



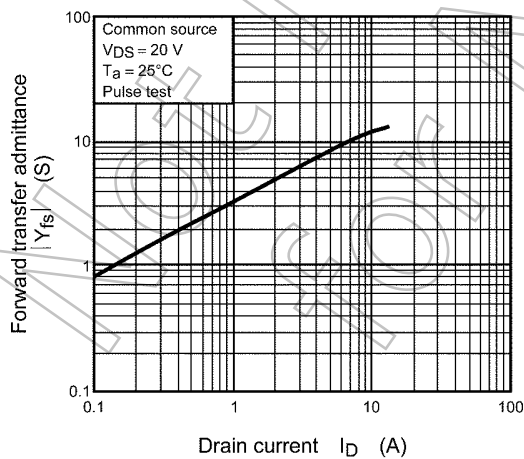
**Fig. 8.2**  $I_D - V_{DS}$



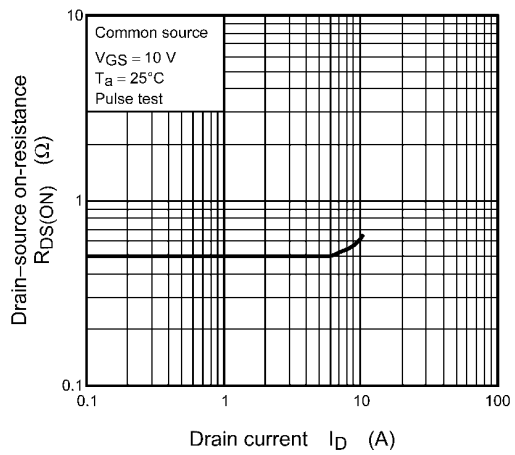
**Fig. 8.3**  $I_D - V_{GS}$



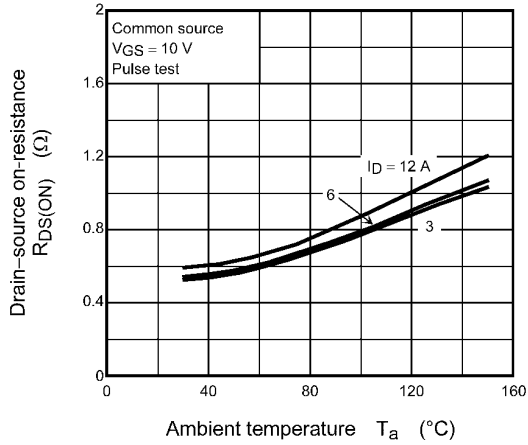
**Fig. 8.4**  $V_{DS} - V_{GS}$



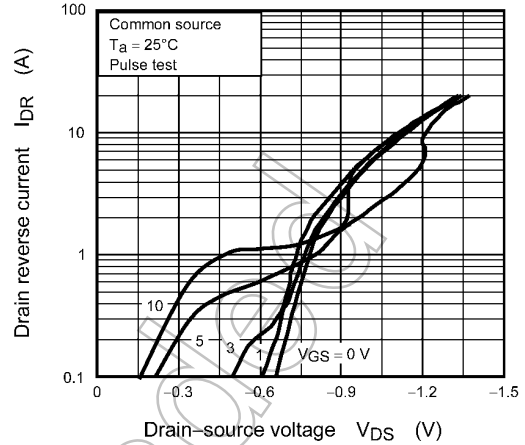
**Fig. 8.5**  $|Y_{fs}| - I_D$



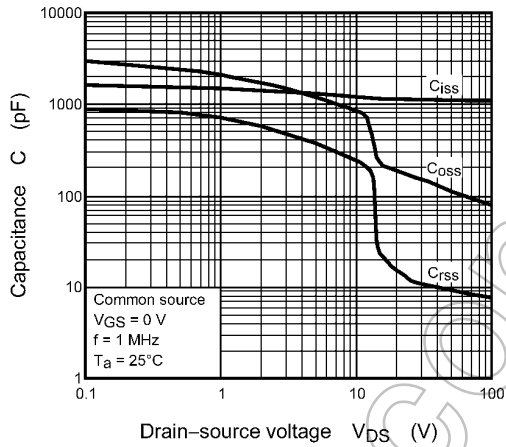
**Fig. 8.6**  $R_{DS(ON)} - I_D$



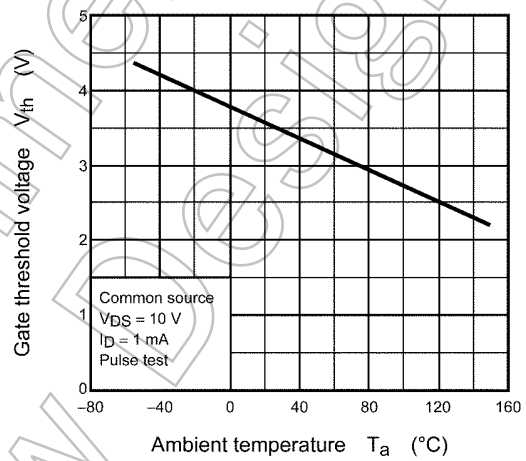
**Fig. 8.7  $R_{DS(ON)} - T_a$**



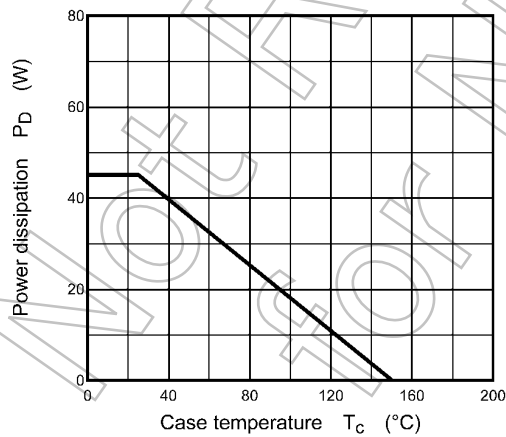
**Fig. 8.8  $I_{DR} - V_{DS}$**



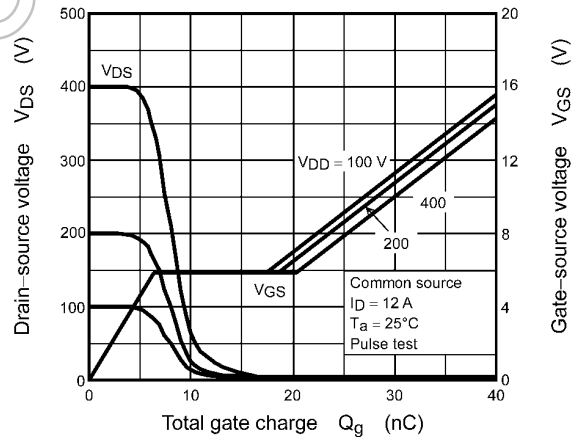
**Fig. 8.9 C -  $V_{DS}$**



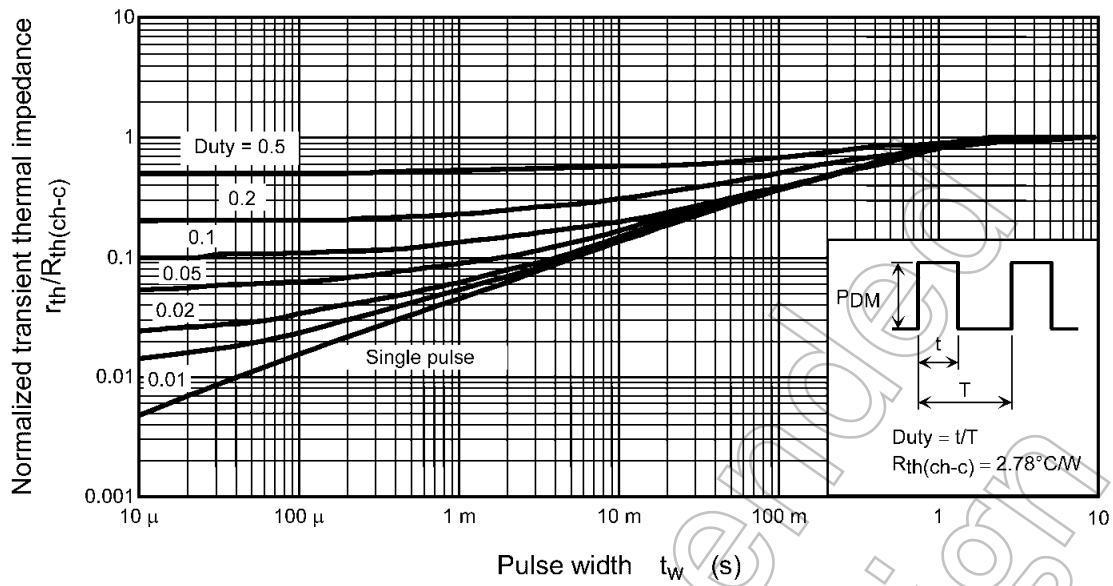
**Fig. 8.10  $V_{th} - T_a$**



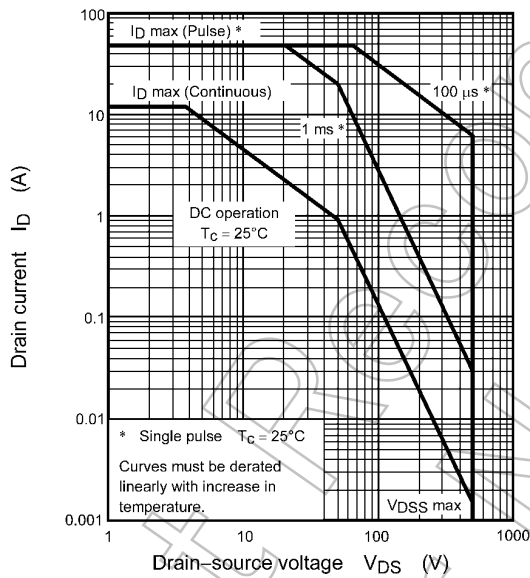
**Fig. 8.11  $P_D - T_C$   
(Guaranteed Maximum)**



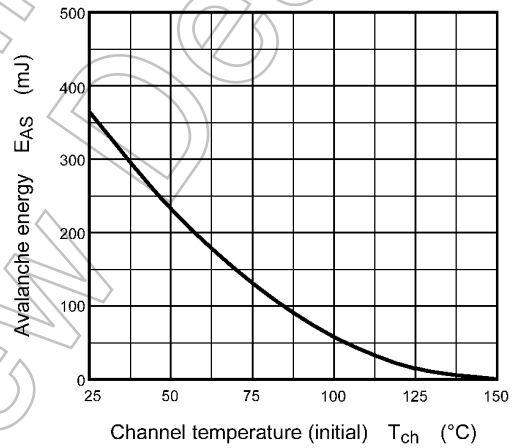
**Fig. 8.12 Dynamic Input/Output Characteristics**



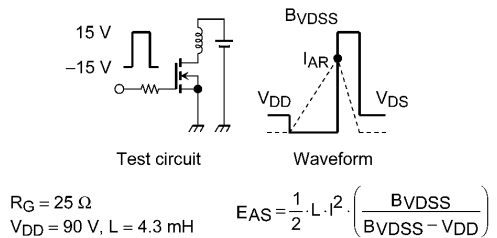
**Fig. 8.13**  $r_{th}/R_{th}(ch-c) - t_w$

(Guaranteed Maximum)

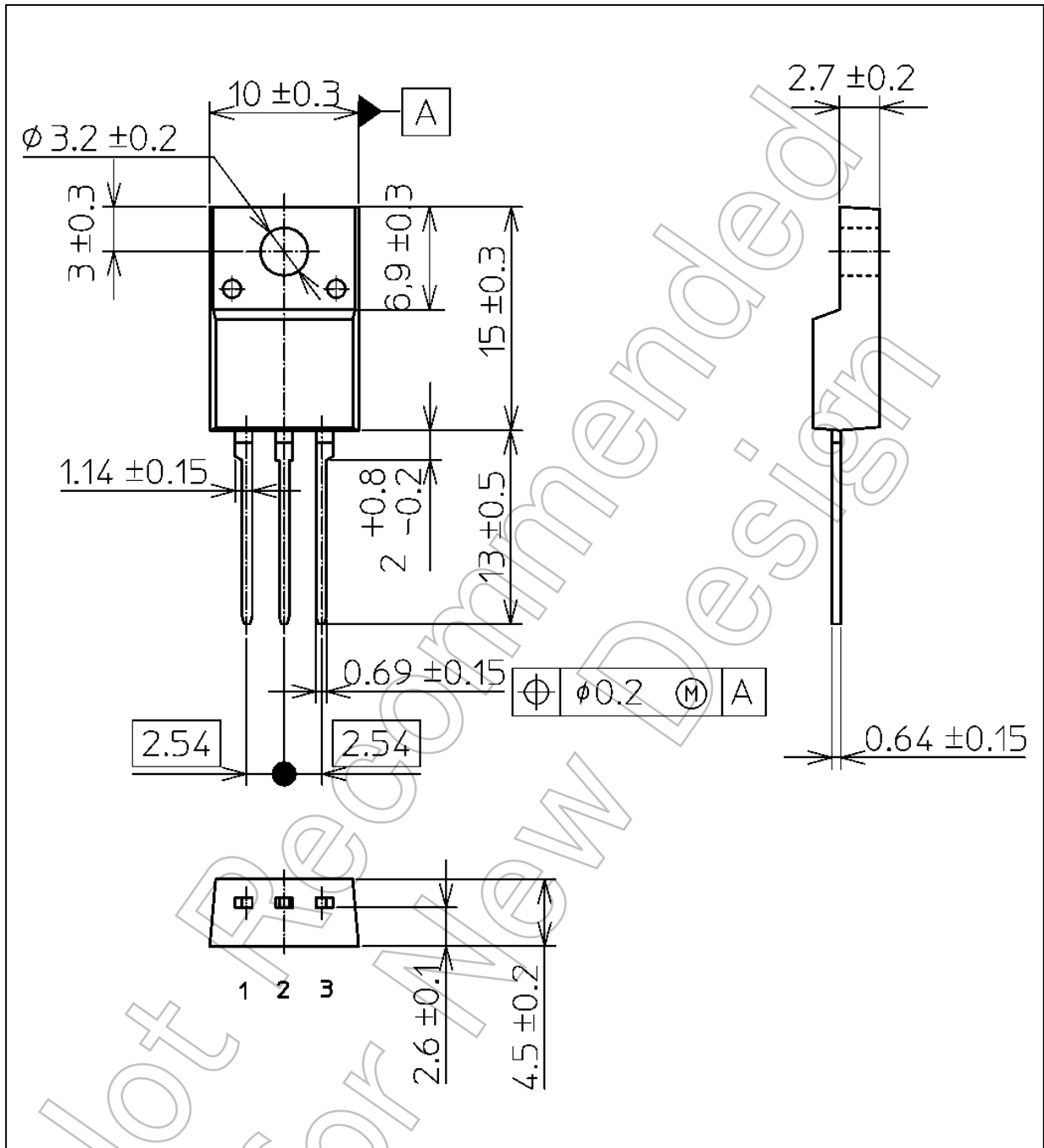


**Fig. 8.16** Test Circuit/Waveform
