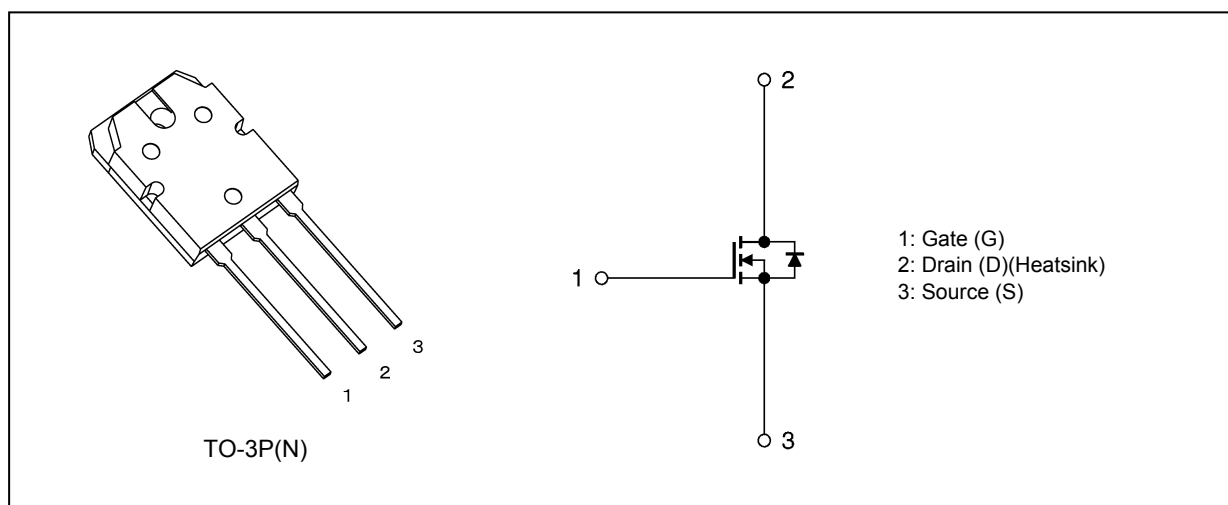

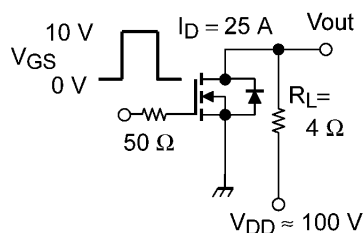

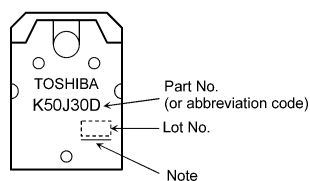
**Fig. 6.2.1 Switching Time Test Circuit**

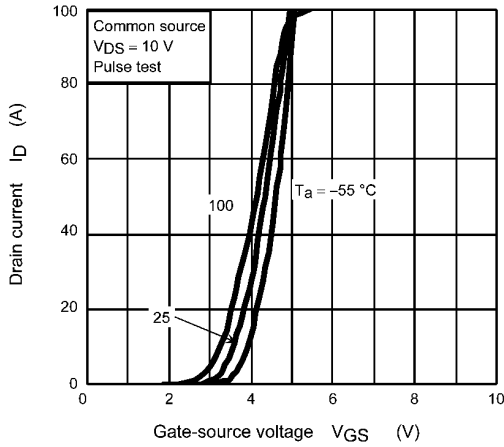

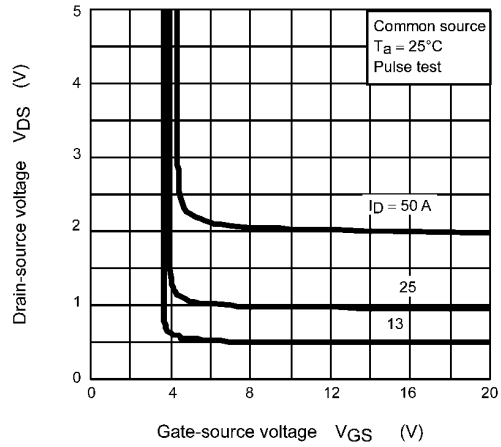
**Fig. 8.1  $I_D - V_{DS}$**



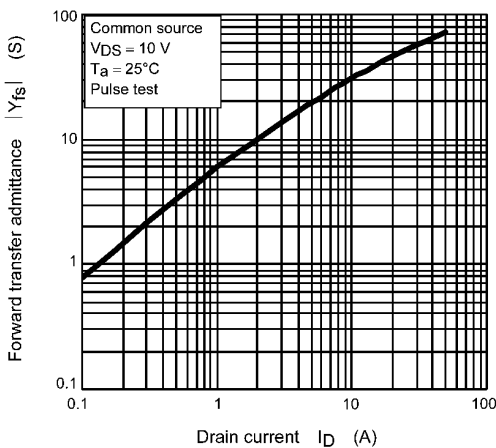
**Fig. 8.2  $I_D - V_{DS}$**



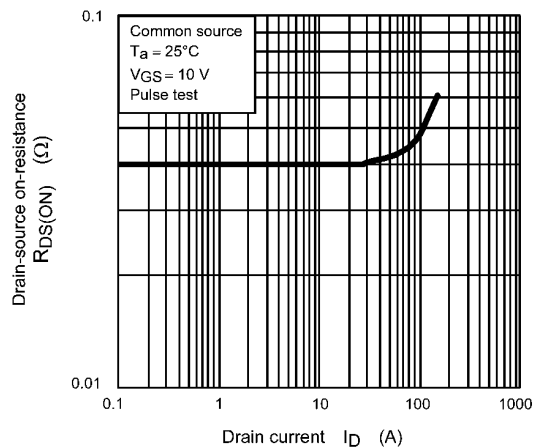
**Fig. 8.3  $I_D - V_{GS}$**



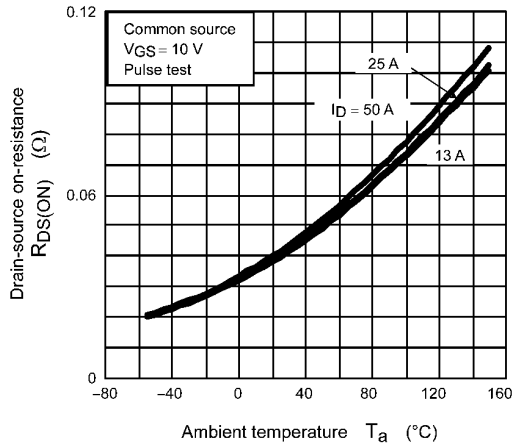
**Fig. 8.4  $V_{DS} - V_{GS}$**



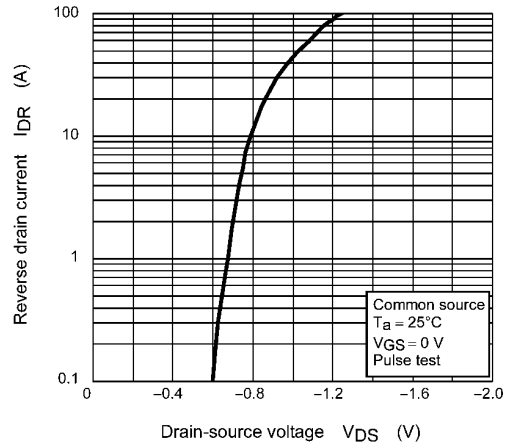
**Fig. 8.5  $|Y_{fs}| - I_D$**



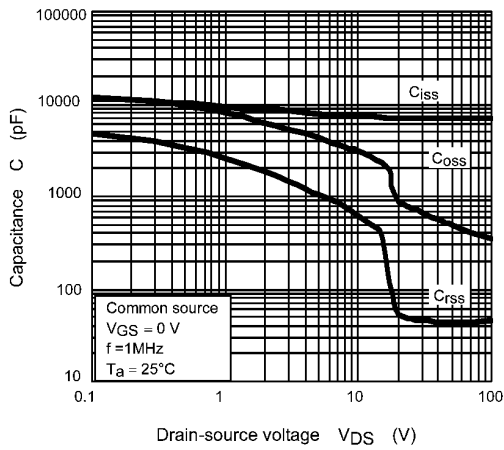
**Fig. 8.6  $R_{DS(ON)} - I_D$**



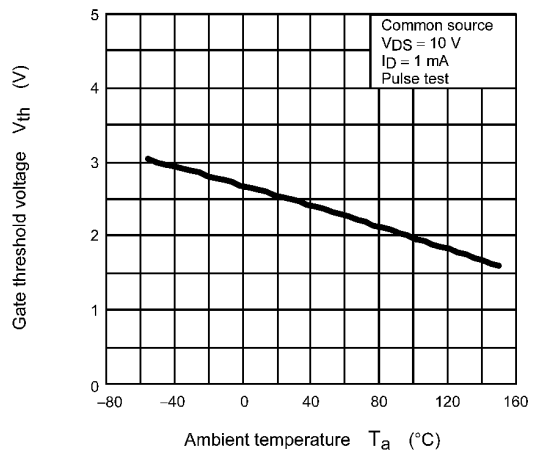
**Fig. 8.7 R<sub>DS(ON)</sub> - T<sub>a</sub>**



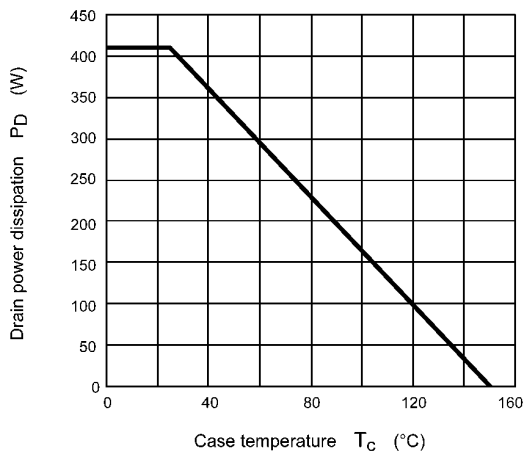
**Fig. 8.8 I<sub>DR</sub> - V<sub>DS</sub>**



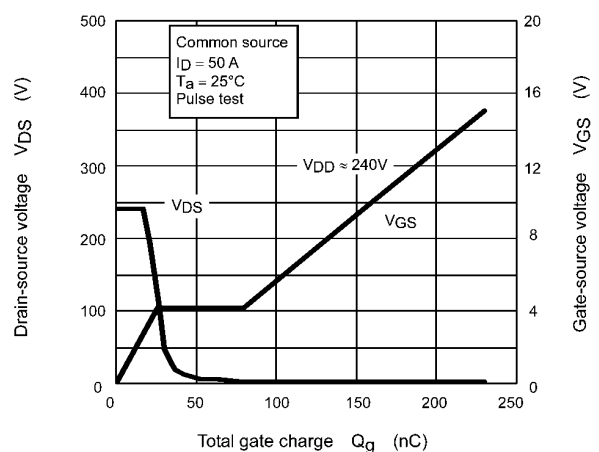
**Fig. 8.9 C - V<sub>DS</sub>**



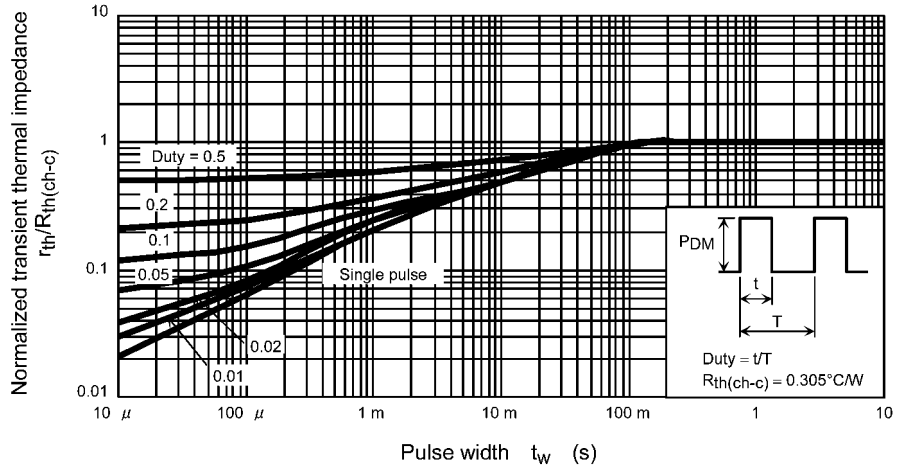
**Fig. 8.10 V<sub>th</sub> - T<sub>a</sub>**



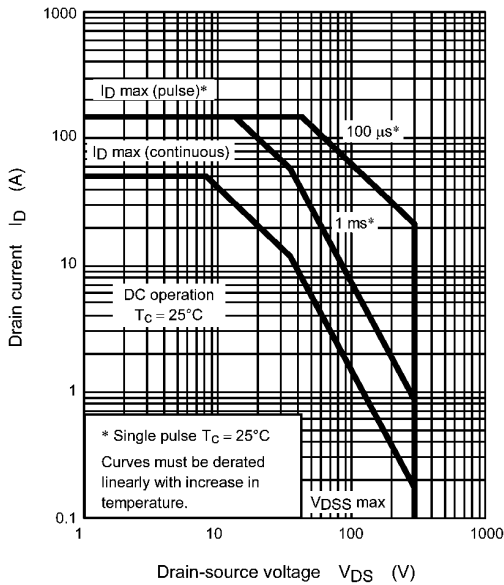
**Fig. 8.11 P<sub>D</sub> - T<sub>c</sub>  
(Guaranteed Maximum)**



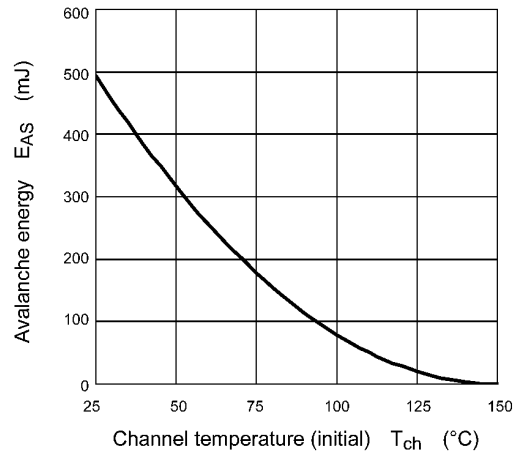
**Fig. 8.12 Dynamic Input/Output Characteristics**



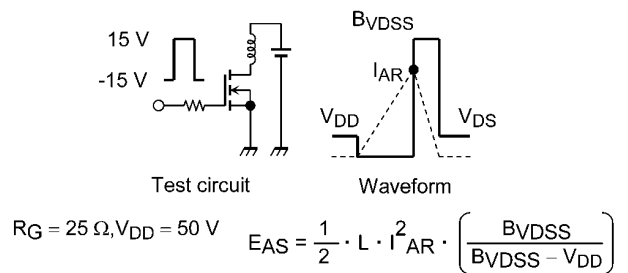
**Fig. 8.13**  $r_{th}/R_{th(ch-c)} - t_w$

(Guaranteed Maximum)

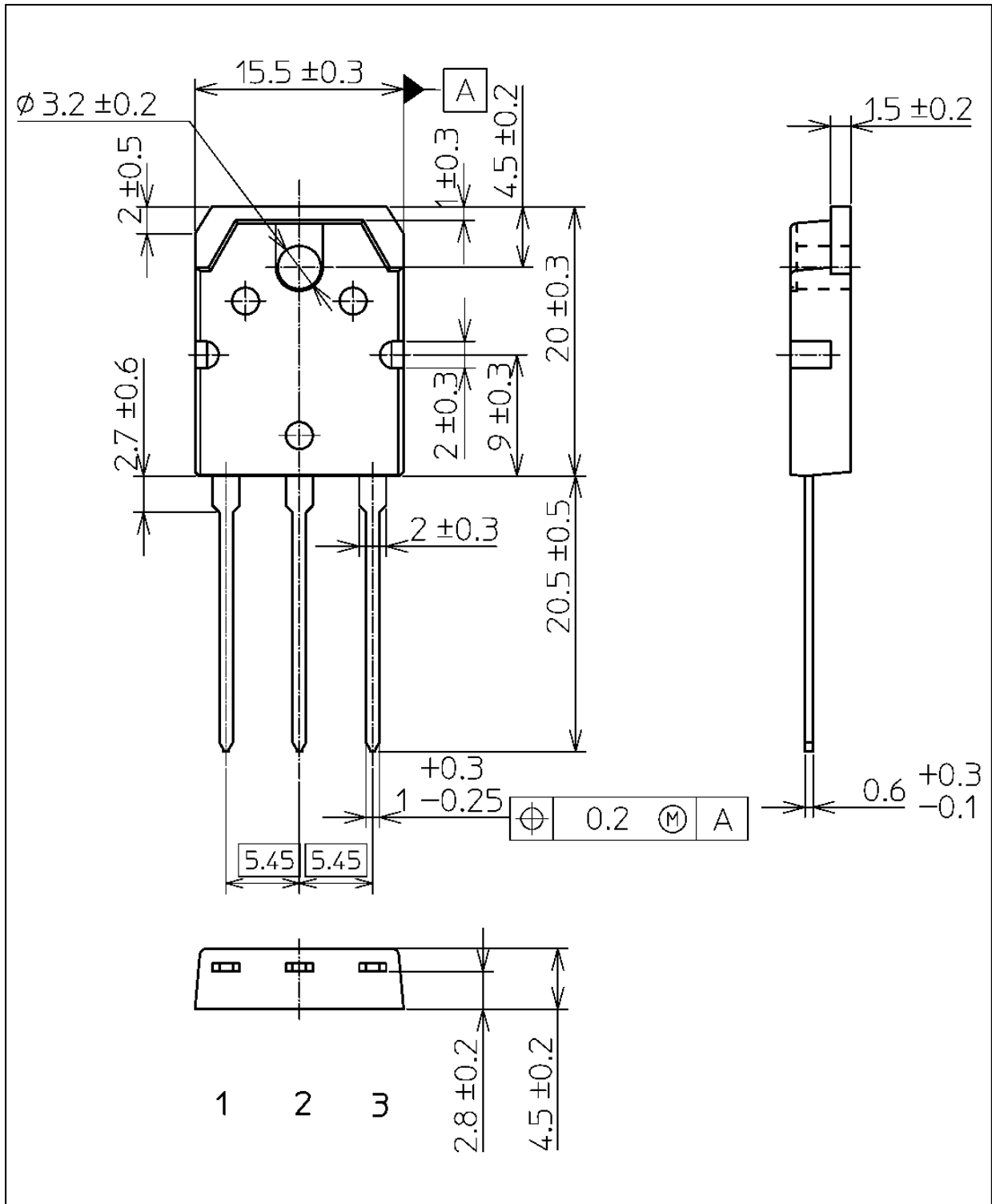


**Fig. 8.16** Test Circuit/Waveform
