




Fig. 5.1 Device Mounted on a Glass-Epoxy Board (a)




Fig. 6.2.1 Switching Time Test Circuit








Fig. 8.7 IDR - VDS




Fig. 8.9 V_{th} - T_a (Note 7)




Fig. 8.11 P_D - T_a (Note 7) (Guaranteed Maximum)




Fig. 8.8 Capacitance - V_{DS}




Fig. 8.10 Dynamic Input/Output Characteristics




Fig. 8.12 r_{th} - t_w (Guaranteed Maximum)




Fig. 8.13 Safe Operating Area (Guaranteed Maximum)







