




Fig. 8.8 Capacitance - VDS







Fig. 8.10 Dynamic Input/Output Characteristics







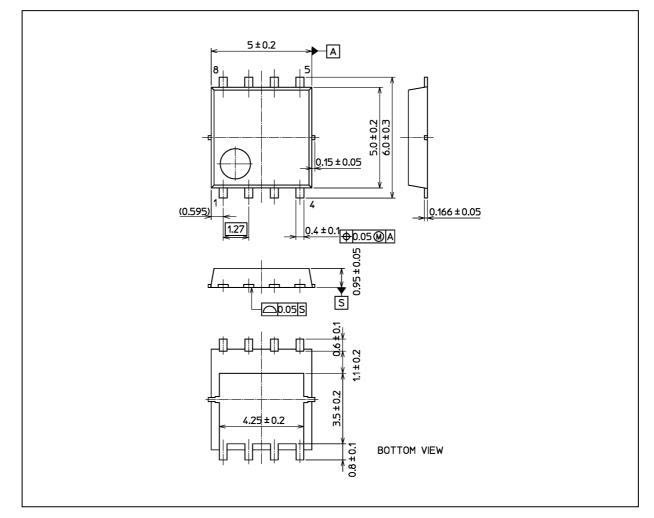
