# 16 GHz INPUT DIVIDE BY 8 PRESCALER IC FOR SATELLITE COMMUNICATIONS

# DESCRIPTION

The  $\mu$ PB1514TU is a silicon germanium (SiGe) monolithic integrated circuit designed as a divide by 8 prescaler IC for satellite communications and point-to-point/multi-point radios.

The package is 8-pin lead-less minimold suitable for surface mount.

This IC is manufactured using our 50 GHz fmax UHS2 (Ultra High Speed Process) SiGe bipolar process.















CIRCUIT CURRENT vs. SUPPLY VOLTAGE



Remark The graphs indicate nominal characteristics.




### **OUTPUT POWER vs. FREQUENCY**





### S11-FREQUENCY





# ILLUSTRATION OF THE MEASUREMENT CIRCUIT ASSEMBLED ON EVALUATION BOARD






### NOTES ON CORRECT USE

- (1) Observe precautions for handling because of electro-static sensitive devices.
- (2) Form a ground pattern as widely as possible to minimize ground impedance (to prevent undesired oscillation).
- (3) Keep the track length of the ground terminals as short as possible.
- (4) Bypass capacitance must be attached to Vcc line.
- (5) Exposed heatsink at bottom on package must be soldered to PCB RF/DC ground.
