The μ PG2162T5N is a GaAs MMIC DPDT (<u>D</u>ouble <u>Pole</u> <u>D</u>ouble <u>T</u>hrow) switch which was developed for 2.4 GHz and 6 GHz dual-band wireless LAN. This device can operate frequency from 2.4 GHz band and 6 GHz band, having the low insertion loss and high isolation.








MOUNTING PAD AND SOLDER MASK LAYOUT DIMENSIONS

SOLDER PAD


