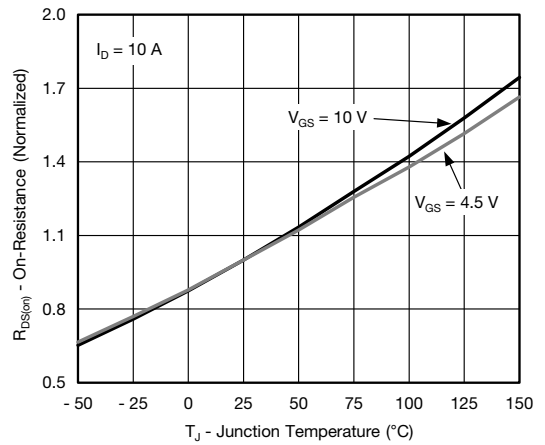
**On-Resistance vs. Drain Current**

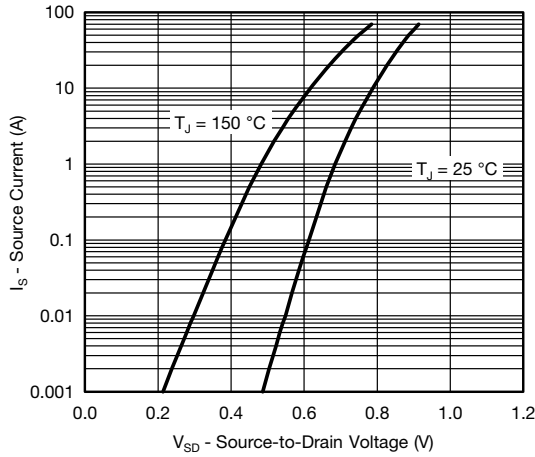

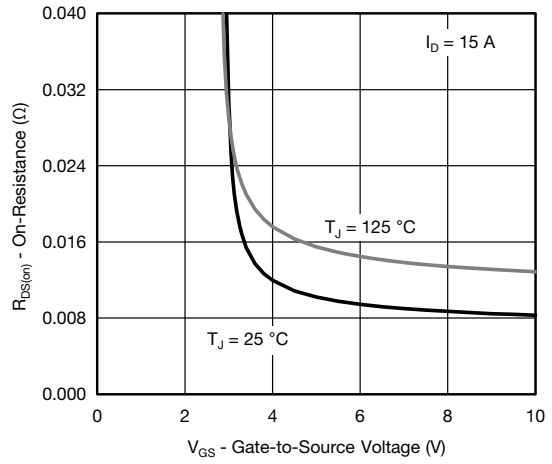


**On-Resistance vs. Junction Temperature**

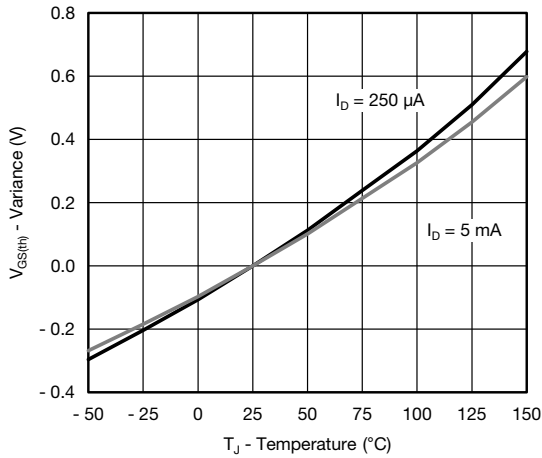

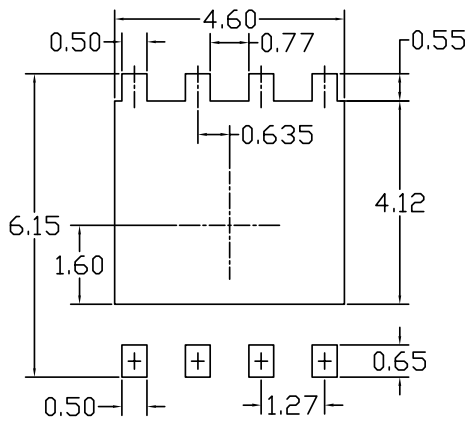

RECOMMENDED LAND PATTERN



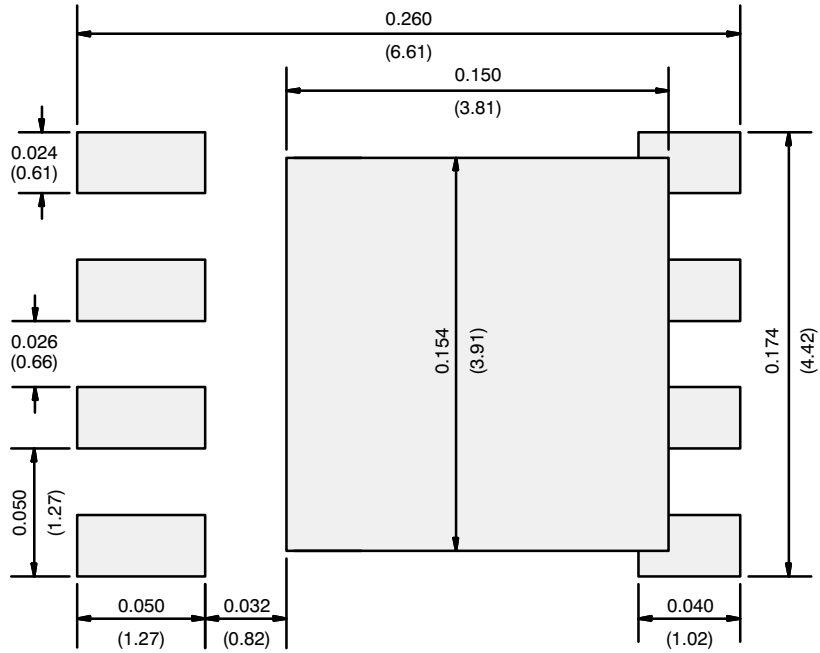
