




Fig. 1 - Input Safety Current vs. Ambient Temperature




Fig. 3 - Load Current vs. Ambient Temperature




Fig. 2 - Output Safety Power vs. Ambient Temperature




Fig. 4 - Timing Test Circuit and Waveforms




Fig. 5 - Forward Current vs. Forward Voltage




Fig. 6 - Forward Current for Switch Turn-On vs.
Ambient Temperature




Fig. 7 - On-Resistance vs. Ambient Temperature




Fig. 8 - Leakage Current vs. Ambient Temperature




Fig. 9 - Turn-On Time vs. Forward Current







Fig. 10 - Turn-Off Time vs. Forward Current




Fig. 11 - Package Drawings





Fig. 12 - VO1400AEF






Fig. 15 - Lead (Pb)-free Reflow Solder Profile According to J-STD-020 for SMD Devices
