




These devices are intended for use in snubber, boost, lighting, piezo-injection, as high frequency rectifiers, and freewheeling diodes.

The extremely optimized stored charge and low recovery current minimize the switching losses and reduce power dissipation in the switching element.




Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 5 - Forward Power Loss Characteristics




Fig. 4 - Maximum Allowable Case Temperature vs. Average Forward Current




Fig. 6 - Typical Reverse Recovery Time vs. dl_F/dt





Fig. 7 - Typical Stored Charge vs. dl_F/dt




