




### Typical Output Characteristics




### Transfer Characteristics




### Static Drain-Source On-state Resistance vs Drain Current




### Static Drain-Source On-state Resistance vs Case Temperature




Gate Threshold Voltage vs Case Temperature




Safe Operating Area




Transient Thermal Impedance




Capacitance Characteristics




Power Derating - Case Temperature



Gate Charge Characteristics




Single Avalanche Energy Derating vs Channel Temperature
