
N-CHANNEL TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)



Drain to Source Voltage Output Characteristics




Gate to Source Voltage Transfer Characteristics




Drain to Source Resistance vs. Gate to Source Voltage



Drain Current








Source to Drain Voltage Body Diode Forward Characteristics




Drain to Source Voltage Capacitances
